



WHICH ARE THE MERIT REQUIREMENTS TO CONFIRM THE EXEMPTION?

To confirm the exemption during the first and second year of the course, students are requested to meet the following three conditions:

1. **Credit Achievement:** Earn the required number of University Credits (CFU) as specified in your Study Plan.
 - o Note: Credits transferred from other universities or obtained through extra-curricular activities (e.g., external language certificates) do not count toward this requirement.
2. **Regular Attendance:** Attend all academic activities as required by the University Regulations.
3. **Academic Results:** Maintain a weighted average grade of at least 27/30. Please note that "Honors" (Lode) are not included in the average calculation.

FEE EXEPTION REVOCATION

The exemption is revoked if the assignee:

- **Fails to meet the merit requirements** indicated in the table;
- **Receives a disciplinary sanction** greater than the warning by the Disciplinary Commission (Article 9 of the Student and Enrollment Regulations¹);
- **Provides untruthful declarations** and/or false documents;
- **Voluntarily interrupts his/her studies;**
- **Reports a change in his/her financial situation** that no longer meets the original criteria.

In this case, the University reserves the right to revoke the exemption.

If the exemption is revoked, the assignee is required to pay the fee for which he/she was exempt.

¹ 9.1 – Students failing to comply with regulations or laws or norms concerning safety in the workplace, pursuant to Leg. Decree 81/2008 and subsequent amendments, both on university premises as well as during study trips, may be subject to disciplinary action; the student must therefore comply with the provisions established in art. 20 of Leg. Decree 81/2008 and subsequent amendments, “Duties and Obligations of the Worker”. Sanctions will be applied for acts occurring on University premises, during study trips, in University Student Housing or anywhere else where students are acting on behalf of or as part of the University.

9.2 – The following disciplinary actions may be taken against students:

- a) verbal warning;
- b) written warning;
- c) temporary suspension from one or more courses or other academic activities;
- d) exclusion from one or more exams or other forms of testing for the entire session, or for part of it, and from academic activities;
- e) temporary suspension from UNISG academic activities and from services provided to the students;
- f) expulsion of the student.

Applied sanctions will be recorded in the student’s university career. Applied sanctions will not undermine the right/obligation of the University To involve legal authorities.

9.3 – The disciplinary authority over the students belongs to the Rector, who has the right to appoint a Disciplinary Commission, composed of at least two professors of the University, the Administrative Director of the University or his/her delegate and at least one student representative. The examination of the case will take place following written and/or oral communication directed at the selfsame Commission. The Disciplinary Commission notifies students of the accusations made against them. The students may mount a defense according to the terms and conditions established by the selfsame Commission
